

## 101.7 THE POINT CONNECT THE DOTS CONTEST RULES

### 1. CONCEPT:

a) To participate, listeners call the 101.7 THE POINT Contest Line, (765) 966-9393, after a sounder is played at the pre-designated times. 101.7 THE POINT will take one caller per contest session. During the call, three “Dots” (clues) are read. The contestant uses the three “Dots” (clues) to guess the correct answer. If the contestant is correct, they win an Amazon 5th Gen Echo Dot. If the contestant is not correct, the contestant is not a winner. 101.7 THE POINT will reveal the correct answer and share how the Dots are related.

b) A Connect the Dots winner is determined on a first-to-answer basis. The contest is played on-air, Monday-Friday, March 25 – April 8, at predetermined times during the morning show on GET UP with Eric.

### 2. PRIZE:

a) The 101.7 THE POINT Connect the Dots eligible prize for each contest session, an Amazon 5th Gen Echo Dot, is valued at approximately \$49.99.
